Approval of Minutes

Governor Schrag called for a motion to approve the minutes of the February 16, 2024, Programs and Planning Committee meeting. Governor Chris Waters provided a motion, receiving a second from Governor Anson Elliott.

Community Graduate Assistant Program

Brad Bodenhausen, Vice President for Community and Global Partnerships; Dr. Julie Masterson, Associate Provost and Dean of the Graduate College; and Dr. Jerry Masterson, Director of Graduate Interdisciplinary Programs, provided a presentation on the Community Graduate Assistant Program. Highlights of their presentation included placement of students, costs for employers, and positive testimonies from both students and community partners.

Learning Management System & Faculty Success Update

Dr. Nancy Gordon, Director for the Faculty Center for Teaching and Learning, provided an update on the implementation of the university's new learning management system — Brightspace. Highlights of her presentation included that as of this spring, 181 faculty from the West Plains Campus and 317 faculty from the Springfield campus have started using Brightspace with student feedback being positive.

Dr. Letitia White-Minnis provided an update on the implementation of Faculty Success, a software solution that maintains information reflected in faculty vitae. She shared that as of this spring, the system has been fully implemented with over 550 faculty submissions.

College and University Professional Association (CUPA) Update

Dr. Ken Brown, Chief Academic Strategy Officer, provided a College and University Professional Association (CUPA) update that included survey results for faculty and staff salary comparisons and additional steps to stay current on data.

- B. R.S.Mo. 610.021(2). "Leasing, purchase or sale of real estate by a public governmental body..."

- D. R.S.Mo. 610.021(6). "Scholastic probation, expulsion, or graduation of identifiable individuals..."
- E. R.S.Mo. 610.021(9). "Preparation, including any discussions or work product, on behalf of a public governmental body or its representatives for negotiations with employee groups;"
- F. R.S. Mo. 610.021(11) and (12). "Specifications for competitive bidding...;" and "Sealed bids and related documents...;"
- G. R.S.Mo. 610.021(13). "Individually identifiable personnel records, performance ratings or records pertaining to employees or applicants for employment...;"
- H. R.S.Mo. 610.021(14). "Records which are protected from disclosure by law;" and
- I. R.S.Mo. 610.021(17). "Confidential or privileged communications between a public governmental body and its auditor,..."
