## **2023 – 2024 Program Report**

## **Trainings, Presentations, and Programs**

**SOAR Parent Presentations** (June 13 – August 3, August 17, 2023, January 9, 11, 2024) – Director of Student Conduct, Gabby Catlin, in collaboration with representatives from the Springfield Police Department and Missouri State University's Office of University Safety facilitated brief presentations to parents twice a week on policies, safety and behavioral expectations for incoming first year students.

**NABITA Behavioral Intervention Team Training** (July 17 - 18, 2023) - Director of Student Conduct, Gabby Catlin, attended a training about the standards of Behavioral Intervention Teams and how to conduct threat assessments led by facilitators from the National Association for Behavioral Intervention and Threat Assessment.

**Hall Director Maxient Training** (July 21, 2023) - Director of Student Conduct, Gabby Catlin, facilitated a training for Hall Directors on how to utilize Maxient throughout the entire adjudication process.

**Hall Director Conduct Training** (July 25, 2023) – Director of Student Conduct, Gabby Catlin, facilitated a training for Hall Directors on the conduct process, including a brief history of student conduct.

**Violence Risk Assessment of the Written Word Training** (July 26, 2023) - Director of Student Conduct, Gabby Catlin, attended a training about how to utilize the Violence Risk Assessment of the Written Word (VRAWW) tool to assess for risk of violence within student writings.

Plaster Student Union, Student Operations Management Team Training (August 9, 2023) - Director of Student Conduct, Gabby Catlin, presented to the Student Operations Management Team in the Plaster Student Union on Incident and Accident Report writing and Maxient.

**Behind Closed Door Scenario Resident Assistant Training** (August 10, 2023) - Director of Student Conduct, Gabby Catlin, presented to Resident Assistants during their scenario response training, specifically discussing the procedures for reporting alcohol and drug policy violations.

**Resource Fair:** (August 15, 2023) - Director of Student Conduct, Gabby Catlin, and Dean of Students Office Graduate Assistant, Makenzie Maxwell, facilitated a table at the Resource Fair held for Resident Assistants and the Executive Board of the Residence Hall Association to explain the operations of the Office of Student Conduct and the Dean of Students office and program collaborations possible with the offices.

**URSA Session:** (August 16, 2023) - Director of Student Conduct, Gabby Catlin, and Office of Student Conduct Graduate Assistant Bethany Littlejohn, facilitated a session for URSA Minor students about the conduct process, including Drunk Goggle Relay activity, and a discussion on policies in the Code of Student Rights and Responsibilities.

Welcome Social for the Bears for a Just Community (August 21, 2023) - Director of Student Conduct, Gabby Catlin, and other staff and faculty partners were invited to an opening social for

the Bears for a Just Community (BJC). This community, a floor of students in Shannon House, is part of the Living Learning Community program for Housing and Residence life. BJC comprises students interested in discussing and serving communities based on social justice and diversity.

Office of Student Conduct Blog Post (August 21, 2023) - Director of Student Conduct, Gabby Catlin, posted a blog on the MSU Office of Student Conduct website welcoming students back to campus and introducing the team.

**House Calls** (August 30, 2023) - Director of Student Conduct, Gabby Catlin, participated in House Calls sponsored through Residence Life, Housing and Dining Services. House Calls is an interactive opportunity for the staff to meet residents on a one-to-one basis by visiting their residence hall rooms.

**Bear POWER Maxient Training** (September 1, 2023) - Director of Student Conduct, Gabby Catlin, facilitated training for new Graduate Assistants working with the Bear POWER program on Maxient and how to utilize it within their area.
