We will be holding interviews for the position hopefully next week on Monday (the 29th). We will choose someone as a board, then you guys will vote yes or no on it at the next General Council meeting on February 5th. We're going to allow those who applied but were not chosen to have the option to come to General Council and give a speech, to avoid any potential bias we as a board may have.  - c. We are introducing a secondary delegate position to come into General Council. While we are encouraging all chapters to bring one, we understand that it's easier for a bigger chapter to bring a second person every other week than it is for a smaller one to do the same. Because of this, we are making the threshold at 40 members in your chapter. This number will be pulled from your university roster from the previous semester.

If you are in Delta Chi, Kappa Sigma, Phi Gamma Delta, Pi Kappa Alpha, Pi Kappa Phi, Sigma Chi, Sigma Nu, Sigma Pi, Tau Kappa Epsilon, or Theta Chi, you have to bring a secondary delegate.

If you are in Alpha Gamma Rho, Alpha Sigma Phi, Delta Sigma Phi, Lambda Chi Alpha, Phi Delta Theta, or Sigma Phi Epsilon, you are encouraged, but not required, to bring a secondary delegate.

You may have noticed that I just said that Sig Ep doesn't have to bring one. I promise this is not because of favoritism to Sig Ep. Their entire executive board is unavailable to come to General Council because this is when they hold their exec meetings. They will be sending someone who is not on exec in the place of their President, and we as a board felt that they would not gain anything by being required to bring two delegates.
