It is important to research Schools of Veterinary Medicine early in your OTC education to determine appropriate prerequisites. Application will include organization involvement, volunteerism, experience with a veterinarian clinic/people, GPA, tracking hours under a Veterinarian, communication/interpersonal skills, etc. All courses are calculated into GPA for Veterinarian applications, even if a course is repeated (no grade replacement for Veterinarian School application GPA).
